DUTIES OF REGIONAL COMMITTEE MEMBER

Having been elected by Member Brigades to be their Representative within an Area Command, the Regional Committee Member is the representative of the Association within his/her Region.

It is important the Association should be seen to have a united voice on matters affecting Brigades.

Duties of the Regional Committee Member

- 1. To assist in the planning and conduct of Championships. To liaise with the Executive of the Association on any matters, which he/she feels, may need assistance in the conduct of a Championship or in any other areas, which may affect the Association. This is achieved by attending and contributing at meetings of the Committee held at regular intervals either in Sydney or a Country area.
- 2. To act as an official at Championships in whatever capacity the Executive of the Association may select.
- 3. To be responsible for, in the Area of that Regional/Metro Command, the formation of a Committee within that Command to assist in the conduct of a Championship in conjunction with appointed Association and Departmental personnel.
- 4. To assist the Host Brigade in the conduct of a Regional/Metro Championship within the Area Command and to act in any official capacity at a Regional/Metro Command, particularly on the Championship Track and as a member of the Protest Committee.
- 5. To assist Member Brigades within Area Commands to achieve greater skills in training methods for championships including distribution and instruction on Rules and Events.
- 6. To assist Member Brigades within Area Commands by having appliances and equipment available for training purposes in conjunction with Assistant Director of Championships (Logistics).
- 7. May be elected as a Member of an Association Sub-Committee. (Eligible to stand for President/Vice President).
- 8. Assist the Department Logistics Equipment Officer/Operational Support to set up Zone Tracks/Hydrant Kit's etc.
- 9. To produce and distribute regular Newsletters within their Regional/Metro Command as approved by the Executive.
- 10. To gain input from Member Brigades to enhance the conduct of Championships.
